Call to Order: Commissioner Neiderer called the meeting to order.

Facilities Master Plan Presentation

Stacy Snyder started by explaining the background of the project and timeline before Kirk Stoner and Brent Durham began the presentation on the main findings and progress to the Commissioners. (See attached presentation)

Commissioner Eichelberger asked for elaboration on where the plan stands now and asked if the recommendation was for one complex to house all county operations. Kirk responded that keeping county offices nearby that provide adjacent services is an idea, but there are many ideas to consider before moving forward.

Commissioner Neiderer asked if the county had ever done a deep dive of this nature into our facilities. Brent shared that in about 2017, there was a look at our facilities but was not as involved as developing an FMP.

Stacy elaborated at the end of the presentation that municipal leaders are being consulted alongside the county and will be providing more updates in future meetings, as well as on the county website page www.cumberlandcountypa.gov/FMP.

Commissioner Foschi emphasized that they are only in the beginning of the planning process, and it is a great time for county employees to share their ideas as this project cannot be done without feedback.
