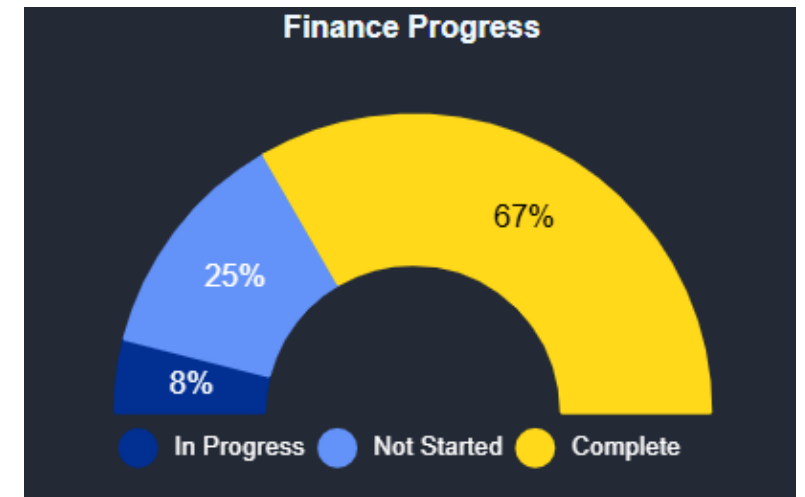
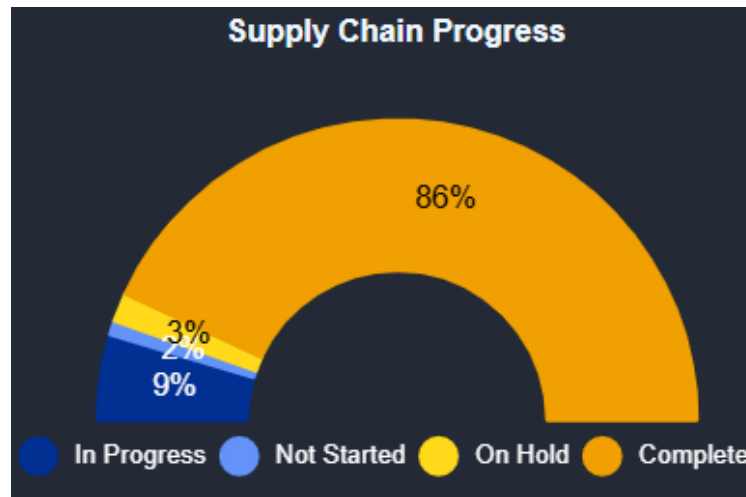
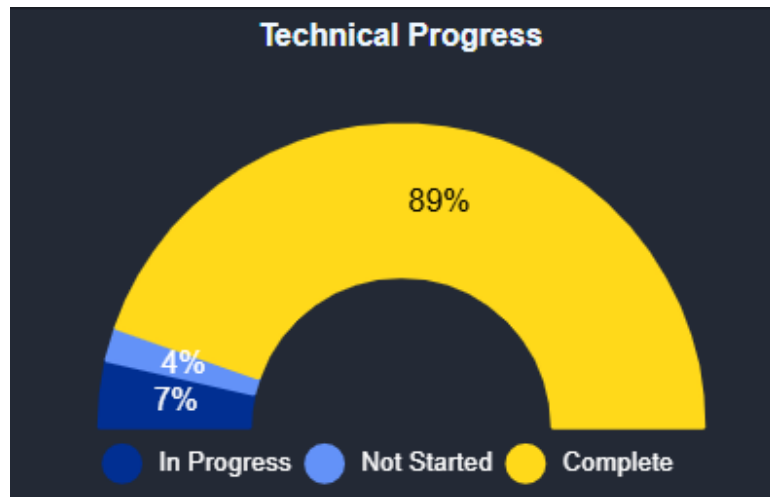

INFOR CLOUDSUITE LEASE ACCOUNTING

IMPROVEMENT OPPORTUNITIES

- Manage all leases regardless of threshold
- Moves lease data from Excel to Cloudsuite with all other financial data
- Enables compliance of all leases and IT arrangements with accounting standards
- Collaborative management of county leases between all responsible parties
 - Eliminates manual processing and tracking efforts
 - Eliminates duplicate efforts
- Ability to automate lease payments both timely and accurately

IMPLEMENTATION SCHEDULE

If approved, the Lease Accounting implementation will align with the current schedule and project plan. Lease Accounting would launch with the FSM portion of the project in November 2025.
