**Call to Order:** Commissioner Neiderer called the meeting to order.

**Roll Call:** Commissioners Neiderer, Foschi, and Eichelberger were present.

**Public Comment:** None.

**Approval of Minutes:** Commissioner Foschi made a motion to approve the meeting minutes of February 12, 2025. Commissioner Eichelberger seconded the motion, and it unanimously carried.

**Employee Recognition: Kristen Day, the District Attorney's Office, for 25 Years of Service**  
Commissioner Neiderer recognized Kristen Day for her 25 years of service to the county. District Attorney Seán McCormack thanked Kristen for her dedication and hard work during her time at the county.

### **Discussion and Approval to Hold Tire Collection and Recycling Events in Collaboration with Vector Control and Keep PA Beautiful at the Recycling Center**

Justin Miller shared a presentation showing photos of previous years events and a cost breakdown for the 2025 potential events (see attached). He proposed having two events, one in the spring and one in the fall. He shared that to align with current costs, he believes that charging \$0.15 per pound is appropriate for the event. Discussion ensued.

Commissioner Eichelberger made a motion to approve to hold tire collection and recycling events in collaboration with Vector Control and Keep PA Beautiful at the Recycling Center. Commissioner Foschi seconded the motion and it unanimously carried.

**Discussion and Possible Motion to Select a Vendor for Solar Energy Facilities on County-Owned Property**

Kirk Stoner shared that after receiving ten responses for the Solar RFP, the recommended vendor for selection is Greenworks and their partner agency Solar Renewable Energy (SRE). He shared that the county would work with PPL to draft a contract to begin the process if a motion was made to select the vendor. Brent Durham shared that there would be immediate and ongoing savings after the solar panels are installed. Discussion ensued.

Commissioner Foschi made a motion to select Greenworks and Solar Renewable Energy for solar energy facilities on County-owned property. Commissioner Eichelberger abstained due to having a professional relationship with one of the principal investors from Solar Renewable Energy.. Commissioner Neiderer seconded the motion. Discussion ensued.

Commissioner Foschi rescinded the motion to select Greenworks and Solar Renewable Energy for solar energy facilities on County-owned property. Commissioner Neiderer seconded rescinding the motion.

**Discussion of and Possible Motion to Authorize the Director of Planning and the Solicitor to Negotiate a Contract with the Selected Vendor Subject to Commissioner Approval**

No discussion was had and no action was taken.

**Adjourn:** With no additional business to come before the Board, Commissioner Eichelberger made a motion to adjourn.
