Call to Order: Commissioner Neiderer called the meeting to order.

Roll Call: Commissioners Neiderer, Foschi, and Eichelberger were present.

Discussion and Approval to Add Agenda Item Discussion and Approval to Cumulate the Write-In Votes as Agenda Item 5

Commissioner Neiderer said that the proposed agenda item was omitted in error, does not include spending of any funds, entering into a contract, and cannot be done at a later date due to the deadline of required submission to the state.

Commissioner Foschi made a motion to add the agenda item Discussion and Approval to Cumulate the Write-In Votes as Agenda Item 5. Commissioner Eichelberger seconded the motion and it unanimously carried.

Public Comment: None.

Approval of Minutes: Commissioner Foschi made a motion to approve the minutes of May 15, 2025. Commissioner Neiderer seconded the motion and it unanimously carried.

Discussion and Approval to Cumulate the Write-In Votes: Bethany Salzarulo reported that the 18,845 write-in votes were compiled with voter intent.

Commissioner Eichelberger made a motion to approve to cumulate the write-in votes. Commissioner Foschi seconded the motion and it unanimously carried.

Discussion and Approval of Action Concerning the Provisional Ballots: Bethany Salzarulo reported there were a total of 84 provisional ballots, and recommended 66 fully count, 3 partially count, and 15 ballots be rejected.

Commissioner Foschi made a motion to approve the action concerning the provisional ballots. Commissioner Neiderer seconded the motion and it unanimously carried.

Discussion and Approval of the Action Concerning the Military and Overseas Ballots: Bethany Salzarulo reported no ballots were received by the deadline and no action is required. No action was taken.

Discussion and Approval to Lay the Result Books on Display: Bethany Salzarulo requested to lay the result books on display until the next Board of Elections meeting and shared that the results would also be posted online.

Commissioner Eichelberger made a motion to lay the result books on display. Commissioner Foschi seconded the motion and it unanimously carried.

Discussion and Approval to Submit the Unofficial Results to the Department of State: Bethany Salzarulo explained the reports reflect everything, including the provisional and write-in ballots.

Commissioner Foschi made a motion to submit the unofficial results to the Department of State. Commissioner Eichelberger seconded the motion and it unanimously carried.

Director Updates: Bethany Salzarulo reported a successful Election Day and thanked county employees for their assistance. Bethany reported that the casting of lots for the Monroe Township Supervisor and East Pennsboro School District ballot position is taking place at noon on June 6.

Request for Executive Session Re: Security Matters: Commissioner Neiderer reported that an executive session regarding security will be held immediately following the meeting.

Other Business: None.

Adjourn: There being no further business to come before the board, Commissioner Foschi made a motion to adjourn.
