Call to Order: Commissioner Neiderer called the meeting to order.

Commissioner Eichelberger made a motion to approve the above contracts for MH/IDD as listed. Commissioner Foschi seconded the motion and it unanimously carried.

Discussion and Possible Approval to Place the Land Partnerships Plan on View

Kirk Stoner requested approval to place the Land Partnerships Plan on view which is the county's plan for farmland preservation, parks, trails and natural resource protection. He explained it's an affiliate plan to our county comprehensive plan. Stephanie Williams presented an overview of the Land Partnerships Plan Update. (see attached)

Stephanie Williams called on members of the Land Partnerships Steering Committee to provide comments.

Anna Yelk stated that the land partnership is such an important part of the comprehensive plan and contains really helpful information for the municipalities to receive.

Julia Chain stated that this plan offers a blueprint to ensure residents have opportunities for a healthy lifestyle, economic growth, and a high quality of life.

Tyler Fairchild stated that this plan helps to mold what the municipalities do as well as provides critical insight into what county residents desire, lays out the core goals and mission, and provides the ideas and the thought process to be able to accomplish those goals.

Tim Johnson expressed his gratitude and support for all the work that went into the plan, all the people that contributed, the outreach, the coordination, and the writing. He shared that this plan is well thought out and really well done.

Commissioner Foschi made a motion to approve placing the Land Partnerships Plan on view. Commissioner Eichelberger seconded the motion and it unanimously carried.

Discussion of the Planning Department Bid Results and Recommendation to Award the County Bridge Maintenance Project to JDI Site Solutions, LLC, and Approval to Issue Notice of Award, Award of Contract, and Execution of the Contract Upon JDI Site Solutions, LLC Meeting All Conditions of the Award

Kirk Stoner recommended JDI Site Solutions for the County Bridge Maintenance Project and requested approval to execute the contract.

Commissioner Foschi made a motion to approve the bid results and recommendation to award the County Bridge Maintenance Project to JDI Site Solutions, LLC, and approval to issue notice of award, award of contract, and execution of the contract upon JDI Site Solutions, LLC meeting all conditions of the award. Commissioner Eichelberger seconded the motion and it unanimously carried.





Future Considerations

- Public polling to establish priority of farmland/parks/trails/natural resources with other county services
- Evaluate dedicated revenue stream
- Organizational capacity of partner organizations
- Investments in county staff deliver results

Land Partnerships Grant Program Relaunch

- \$650,000 currently available, plus pending 2025 allocation
- Focus on high priority projects = open space preservation and trails
- October 1 relaunch
- Rd 1 Deadline = December 12
- Rd 2 Deadline = June 26

Proposed Next Steps

- Release Plan to Public - August 6
- 30 Day Public Comment - August 6 -September 5
- Final Plan Edits - September 8 - 10
- Plan Adoption - September 11
