NOTICE IS HEREBY GIVEN by the Board of Commissioners of Cumberland County, Pennsylvania, of its intention to consider for adoption, and to vote upon enactment of, an ordinance set forth in full hereafter, at its scheduled meeting to be held on Monday, December 8, 2014 at 2:00 pm in the Commissioners' Hearing Room, 2nd floor, Cumberland County Courthouse, One Courthouse Square, Carlisle, Pennsylvania, or at another public meeting at said location not less than seven (7) nor more than 60 days following publication of this notice.

CUMBERLAND COUNTY BOARD OF COMMISSIONERS ORDINANCE 2014-4

Ordinance establishing taxes for 2015 for Cumberland County, being millage for real estate and setting a discount of two per centum for prompt payment and a penalty of ten per centum for late payment of taxes imposed by the County of Cumberland for 2015 and thereafter.

The Board of Commissioners of Cumberland County ordains and enacts:

SECTION 1. Taxes for fiscal year January 1 to December 31, 2015 for the County of Cumberland are as follows:

A. A tax on real property located within the County of Cumberland for 2015 is levied and assessed at the rate of 2.195 mills on the assessed valuation thereof (\$.2195 on each \$100 of assessed valuation of taxable property).

B. A tax on real property located within the County of Cumberland for 2015 is levied and assessed at the rate of .143 mills on the assessed valuation thereof (\$.0143 on each \$100 of assessed valuation of taxable property) for the Cumberland County Library System.

SECTION 2. In accordance with the Act of April 18, 1978, P.L. 56 No. 26, Section 1, 72 P.S. 4821.1, the Board shall not impose or collect for the calendar year of 2015 the Personal Property Tax authorized under the Act of June 17, 1913, P.L. 507.

SECTION 3. Taxes assessed and levied are necessary and sufficient together with all other estimated revenues and balances of the County, to raise a sufficient sum to meet expenditures.

SECTION 4. The rate of the discount for payment of taxes assessed by the County shall be two per centum (2%) from the amount of such tax upon making payment of the whole amount thereof within two months after the date of the tax notice.

SECTION 5. All taxpayers who shall fail to make payment of any such taxes charged against them for four months after the date of the tax notice shall be charged a penalty of ten per centum (10%), which penalty shall be added to the taxes by the tax collector and be collected by him or her.

SECTION 6. The Chief Clerk shall notify all tax collectors of the contents of this Ordinance.

SECTION 7. The discount and penalty apply to taxes imposed for 2015 and thereafter.
