

PLAN SUBMISSIONS

The Municipalities Planning Code (MPC) requires municipalities to forward all subdivision and land development plans to the Cumberland County Planning Commission (CCPC) for review and comment. The CCPC uses the residential, commercial and industrial proposals shown on final plan submissions to assess future growth potential in the county. The following data summarizes the development proposals reviewed in 2023.

Number and Location of Plan Submissions


A total of 161 plans were submitted for review in 2023 (9 preliminary plans and 152 final plans). This is 4% less than the 168 plans submitted in 2022. This map indicates the proposed land use type and the location of each plan. Clusters of activity can be found around the Borough of Shippensburg, The Borough of Carlisle, along State Route 11 east of Carlisle and along Route 15. Residential Plan Submissions

Final plan submissions included a total of 1,137 new residential units in Cumberland County. This is 33% less than the 1,700 residential units proposed in 2022. 1,014 of the proposed units (89%) are concentrated in five municipalities (see table on page 3). Multi family units (554) comprised nearly half of the total number of proposed units with single family detached (496) and townhouses (87) combining for the remaining proposed residential units. Major residential proposals in 2023 included:


- Grange Phase 1 and 2 in Middlesex Township (234 single family detached units and 280 multifamily units). The entire sketch plan for the Grange development proposes 1,300 units.
- 199 Associates Lot 2 in East Pennsboro Township (174 multi family units).
- Legacy Park in Mechanicsburg Borough (87 single family detached units).



Nonresidential Plan Submissions

A total of 66 nonresidential units comprising 3,082,062 square feet of floor area were proposed in 2023, a 14.3% increase from 2022. The AAMPA Holdings plan in West Pennsboro Township proposed a 1,355,984 square foot warehouse which accounted for (44%) of the total nonresidential floor area. Other notable nonresidential proposals include:

- The Costco plan in Silver Spring Township proposes 161,141 square feet of retail space.
- The Life Care Facility (Lot 4) plan in South Middleton Township proposes 141,900 square feet for a senior living facility.
- The Beltway Commons plan in Hampden Township proposes 132,144 square feet of retail space.



2023 Proposed Growth

The table on the right compares the 2023 proposed development to the 2022 development as well as a 5-year average. Cumberland County experienced lower residential growth and above average commercial / industrial growth in 2023.

The table below lists the municipalities that experienced the most proposed growth in 2023. The table on page 4 provides proposed growth statistics for each municipality. The final plans submitted in these municipalities includes future development that will be constructed and reflected in completed building permits in coming years.


BUILDING PERMITS

The CCPC cooperates with the Cumberland County Tax Assessment Office to identify the building permits that were completed in the county and added to the tax rolls. The Tax Assessment Office provides monthly summaries of completed building permits to the CCPD. The data includes the new commercial value for each unit that enables the county to estimate its growth in taxable assessments. The following data summarizes the building permits that were completed in 2023.

Residential Building Permits

1,162 residential building permits were completed in 2023. 700 (60%) of the residential permits were completed in the top four municipalities listed on the next page. Major residential building permits completed in 2023 include:

- Northside Village in Carlisle Borough includes 119 apartment units.
- Hadley Place in Hampden Township includes 112 apartment units.
- The Terraces at Shepherdstown in Upper Allen Township includes 37 apartment units.
- Legacy Park in Mechanicsburg Borough includes 36 units.



Nonresidential Building Permits

A total of 24 commercial and three industrial permits were completed in 2023 with 15 (56%) of those projects located in the top five municipalities listed on the next page. Major nonresidential projects completed in 2023 include:

- CSHV Penn Commerce II, LLC at Centerville Road in Penn Township. This 753,000 square foot warehouse increased the commercial value by \$35,356,600.
- SDKM Bear Property LLC at 221 Allen Road in West Pennsboro Township. This permit is to add an additional 362,888 square foot warehouse that increased the commercial value by \$13,788,700.
- Smith Land and Improvement Corp. at 425 Lambs Gap Road in Hampden Township. The assisted living facility includes 125 beds increased the commercial value by \$12,862,300.
- Sunrise Land Holdings, LLC at 125 State Road in Silver Spring Township. This personal care home increased the commercial value by \$5,238,500






