### **Board Member Needed for Susquehanna Regional Transportation Authority**

*Deadline to Apply for Volunteer Board Member Opening is Monday, April 22, at 4:30 p.m.*

**Carlisle, PA** – The Cumberland County Board of Commissioners is looking for a volunteer board member to serve on the Susquehanna Regional Transportation Authority (SRTA). The appointee will act on behalf of the board of commissioners to represent the best interests of the county.

SRTA, doing business as rabbittransit, is a regional public transportation provider, offering a variety of transportation services to the residents of Adams, Columbia, Cumberland, Franklin, Montour, Northumberland, Perry, Snyder, Union, and York Counties.

The board meets on the fourth Thursday of each month at 10 a.m. in the organization's headquarters in Harrisburg and York. Board members are also expected to attend annual retreats and ad hoc meetings, as necessary. In-person attendance is expected with a virtual option provided for extenuating circumstances.

This new board member would serve a 5-year-term expiring May 2029.

#### **Qualifications:**

- Cumberland County resident (taxpayer or business owner).
- Demonstrated interest in the health and wellbeing of the county and the region.
- Interest in public transit and transportation needs.
- Critical thinker, with the ability to interpret financial and performance data.
- Awareness of the service providers and/or customers who use the system.
- Basic knowledge of social economics, land use, transportation, and demographic characteristics of the county and service area.
- General understanding of state, national, and internal influences that impact transportation services.
