Recovery houses are apartment buildings shared by people in recovery. Residents pay weekly rent and are expected to abide by house rules and regulations, including staying sober and attending 12-step meetings. Scholarship funding may be available.

Information and Administrative Services

The administrative services of the Commission include the planning, contracting, program monitoring, and overall coordination of government-funded drug and alcohol services in Cumberland and Perry counties. Case Management services are provided to clients receiving Commission-funded inpatient treatment. If a person is under the influence of alcohol or other drugs, or in acute withdrawal, do not hesitate to contact the closest detox facility for guidance.

Detoxification Services

Detoxification services usually include short-term treatment in either a hospital or non-hospital facility. "Detox" is the process of eliminating drugs or alcohol from the body through a period of supervised abstinence while safely managing any accompanying withdrawal symptoms. Clients also receive structured education and counseling during this process and assistance in planning continuing treatment at a facility appropriate to their needs.

Treatment Options

The Commission contracts with a variety of facilities in an attempt to meet individual client needs. To access treatment, call one of the listed outpatient agencies. If an individual needs immediate care due to intoxication or other problems, call one of the detox units listed above. If you are unsure, call the Commission. Any of the listed service providers will help you find an appropriate treatment service, which may include outpatient, inpatient or other specialized care. A brief description of these services follows.

Priority Populations

In accordance with federal regulations, preference in accessing Commission-funded substance use disorder treatment is given to the following priority populations in the order outlined: pregnant women who inject drugs; pregnant women who use substances; persons who inject drugs; overdose survivors; and veterans.

Inpatient and Halfway House Services

Funding for inpatient treatment services is available through the Commission. Admission is based on Case Management assessment and eligibility for funding for this level of care. Inpatient services include intensive counseling, educational support, and group treatment activities within a residential, therapeutic facility. These services require that the client reside at an inpatient center in order to receive effective treatment of advanced drug and alcohol problems. A length of stay for inpatient care may range from 14 to 90 days, depending upon individual client needs. Continuing treatment at the halfway house or outpatient level will follow the completion of inpatient treatment.

Methadone Outpatient Treatment

The Commission provides funding for medically supervised medication-assisted treatment to promote successful recovery from addiction to heroin, prescription painkillers, and other opioids.
