

## RESOLUTION NO. 2025-11

### RESOLUTION OF THE CUMBERLAND COUNTY BOARD OF COMMISSIONERS ESTABLISHING A SOLID WASTE ADVISORY COMMITTEE

WHEREAS, the Municipal Waste Planning, Recycling and Waste Reduction Act, Act 101 of 1988, as approved July 28, 1988 (53 P.S. §4000.101 et. seq.), ("Act 101"), gave Cumberland County (the "County") primary responsibility for planning for municipal waste management within its boundaries; and

WHEREAS, Act 101 directs the County to prepare a Municipal Waste Management Plan (the "Plan"); and

WHEREAS, Act 101 directs the County to form an advisory committee prior to preparing a Plan or substantial Plan revision; and

WHEREAS, the Cumberland County Commissioners recognize the importance of developing comprehensive and sustainable solid waste management practices; and

WHEREAS, Cumberland County has a Solid Waste Department that carries out all necessary functions relating to County solid waste and recycling matters; and

WHEREAS, public input and expertise are vital to inform decision-making on solid waste policies and programs.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of Cumberland County, Pennsylvania, as follows:

#### Section 1: Establishment of Committee

A Solid Waste Advisory Committee is hereby established to advise the County Commissioners, through regular meetings with its Solid Waste Department, on matters related to solid waste management.

#### Section 2: Composition

- The Committee shall consist of seven members appointed by the County Commissioners, representing diverse interests such as:
  - the three classes of municipalities within the county
  - citizen organizations
  - industry
  - the private solid waste industry operating within the county
  - the private recycling or scrap material processing industry operating within the county
  - any other persons deemed appropriate by the county

### Section 3: Initial Members and Terms

The names and terms of office of the first members of the Solid Waste Advisory Committee, who shall serve commencing on the date this Resolution is adopted, are:

- David Lenker II – 2 years
- Barbara Arnold – 2 years
- Lauren Dennen – 2 years
- Kami Labell – 1 year
- Marcy Robey – 1 year
- Luke Arnold – 1 year
- Matt Steiman – 1 year

Thereafter, members of the Committee shall be appointed to serve for terms of two years

### Section 4: Procedures

- The Committee shall establish its own rules and procedures for meetings, including the selection of a Chair and Vice-Chair.

### Section 5: Effective Date:

This Resolution shall take effect upon adoption.


