The sole purpose of this document is to amend a previously approved Clean & Green application. A \$17.00 recording fee and a UPI fee of \$20.00 made payable to the Recorder of Deeds, must accompany this amendment.

Definitions

- Split off** - A division by conveyance or other action of the owner of land preferentially assessed under the act into two or more tracts of land, the use of eligibility for Clean & Green.
- Separation** - A division by conveyance or other action of the owner of lands preferentially assessed under the act into two or more tracts of land, the use of which continues to meet the requirements of eligibility for Clean & Green.
- Transfer** - A conveyance of all of the enrolled land described in a single application for preferential assessment under the act.
- Termination** - The right to terminate preferential assessment of enrolled land subject to rollback taxes even when it comes to meet the requirements of eligibility for Clean & Green

Definitions.

- Agricultural Use** - Land for the purpose of producing and agricultural commodity.
- Agricultural Reserve** - Noncommerical open space lands used for outdoor recreation enjoyment of scenic or natural beauty and open to the public for that use, without charge or fee.
- Forest Reserve** - Land, 10 acres or more, stocked by forest trees of any size and capable of producing timber or other wood products.
