

## Erosion & Sedimentation (E&S) Control and Post Construction Stormwater Management (PCSM) Application Package

### REVIEW TIMES:

Non NPDES permitted sites:	35 calendar days for E&S technical review

### ADMINISTRATION:

All NPDES permit NOI/applications require submitting all items on the *General PAG-01 or PAG-02 NOI Checklist or the Individual Permit Application Checklist*. **Please fold plan sets for processing.**

The Conservation District will review the E&S plan/NOI/Application solely to determine whether it is adequate to satisfy the requirements of Title 25 PA Code Chapter 102, the erosion and sediment control and stormwater management regulations of the Department of Environmental Protection. By a determination that the plan is adequate to meet those requirements, neither the District nor the County assumes any responsibility for the implementation of the plan or the proper construction and operation of the facilities contained in the plan. The design, structural integrity and installation of the best management practices are the responsibility of the landowner and/or contractors. **NOTE:** Before any construction or earthmoving begins, other local, state and/or federal permits may be required from other permitting agencies.

### E&S SERVICE FEE SCHEDULE (exemptions on page 4):

This service fee is for plan review and site inspection services for requirements under the Chapter 102, Erosion and Sedimentation Control Program. The service fee covers initial plan submission and one re-submission. **Plans that need reviewed for a third and/or subsequent time, will be charged 25% of the full E&S service fee. The service fee for non-typical plan submissions may be determined on a case by case basis.**

### PCSM SERVICE FEE SCHEDULE (exemptions on page 4):

This service fee is for review and inspection services associated with Individual NPDES permit applications and General NPDES permits requiring a PCSM technical review. These services are performed by Conservation District staff in coordination with PA DEP. **Plans that need reviewed for a third and/or subsequent time or an applicable site restoration plan, will be charged 25% of the full PCSM service fee. The service fee for non-typical plan submissions may be determined on a case by case basis.**

### WITHDRAWN APPLICATION POLICY:

The following policy has been developed in addition to the current Chapter 102 regulations regarding a withdrawn NOI/application:

1. Fees submitted with the application will not be refunded. 102.6(c)(3)
2. Upon re-application, all fees required by regulation must be submitted. 102.6(b)(1)
3. Withdrawn applications that do not change the scope of the project and are submitted within 180 days of withdrawal will be required to pay 25% of the original Erosion & Sedimentation (E&S) Control Service Fee and 25% of the original Post Construction Stormwater Management (PCSM) Service Fee (for individual permits). 102.6(b)(3)
4. Projects submitted after 180 days from withdrawal will be considered a new project and will require all new District fees based on the current fee schedule.

**FEE EXEMPTIONS:**

CCCD Service Fees (E&S SERVICE FEE & PCSM SERVICE FEE) – Municipalities, Chapter 105 GP E&S reviews and Cooperating Agencies listed on the districts cooperating agency list (updated annually) as well as agencies listed in the NOI/Application Instructions are exempt, unless specified through another agreement.

NPDES Administrative Filing Fee and DEP Disturbed Acre Fee – Agencies listed in the Fee Exemption section of the NOI/Application instructions are exempt.

**E&S SERVICE FEE:**

Fees are based on the total number of disturbed acres which include all utility rights-of-way, offsite support activities, access roads and areas large enough for contractor to perform proper grading.

**RESIDENTIAL DENSITY FACTOR FEE (Does not apply to PAG-01):**

This fee is applied to projects that propose a residential density greater than one unit per acre of earth disturbance. A unit is defined as a dwelling designed to accommodate a single household. Multi-story residential buildings will have the fee based on the number of lowest living level units, not total units. Townhomes can apply a 50% reduction to overall townhouse units. (i.e: 30 townhouse units, use 15 residential units to calculate the fee)

Example: 10 units, 7 disturbed acres

Residential density factor would apply because density is greater than 1 unit / disturbed acre (10 / 7 = 1.4)

E&S Service Fee calculation: \$1500 + (\$275 x 7) = \$3425

Residential Density Factor: \$3425 x 25% = \$856.25

**Total E&S Service Fee: \$3425 + \$856.25 = \$4281.25**

**PAG-01 GENERAL PERMIT:**

The PAG-01 General Permit may be used for NPDES permit coverage when the area of an earth disturbance will be less than five (5) acres and when a project is otherwise eligible in accordance with the PAG-01 NOI Instructions and the General Permit. Please refer to **3800-PM-BCW0404a** PAG-01 NOI Instructions for eligibility criteria.
