Cumberland County Election News: Additional Hours Announced to Hand-Deliver Absentee & Mail-in Ballots

Last day to apply for an absentee or mail in ballot is Tuesday, Oct. 28

Carlisle, PA – The Cumberland County Bureau of Elections has announced additional hours for residents to hand-deliver their voted mail-in or absentee ballots for the Municipal Election. Voters may hand-deliver their ballots during regular business hours, Monday through Friday, from 8 a.m. to 4:30 p.m., or during the following extended hours:

- Wednesday, Oct. 29, from 4:30 p.m. to 7 p.m.
- Saturday, Nov. 1, from 9 a.m. to 1 p.m.

Voted ballots can be hand-delivered to the Bureau of Elections at 1601 Ritner Highway, Suite 201, Carlisle. No other voter services will be available during these additional hours.

The Bureau of Elections is also open Tuesday, Nov. 4, Election Day, from 7 a.m. to 8 p.m. The upcoming Municipal Election is **Tuesday, Nov. 4**. Offices up for election include:

- **Statewide** – Judge of the Superior Court and Judge of the Commonwealth Court
- **Cumberland County** – Judge of the Court of Common Pleas, Clerk of the Criminal Court, Controller, Coroner, Magisterial District Judges, Prothonotary, Recorder of Deeds, Register of Wills, and Sheriff
- **Local** – Auditors, Borough Council, Inspectors of Elections, Judges of Elections, Mayors, School Directors, Tax Collectors, Township Commissioners, and Township Supervisors.
- **Retention Election** – Justice of the Supreme Court (3), Judge of the Superior Court (1), Judge of the Commonwealth Court (1), and Judge of the Court of Common Pleas (1).

Last day to apply for a [mail-in or absentee ballot](#): Tuesday, Oct. 28. (*Postmarks will not be accepted*)

Last day to receive voted [mail-in or an absentee ballot](#): Tuesday, Nov. 4.

- On Election Day, The Bureau of Elections Office, 1601 Ritner Highway, Suite 201, Carlisle will be open from 7 a.m. - 8 p.m. for voters to hand-deliver their voted ballots. Ballots must be received by 8 p.m. (*Postmarks will not be accepted*)

Last day to receive voted [military and overseas absentee ballot](#): Wednesday, Nov. 12.

- Ballots must be submitted for delivery no later than **Monday, Nov. 3, by 11:59 p.m.**

The Cumberland County Bureau of Elections is charged with running a fair, safe, accurate and secure election for our voters and residents. The office maintains voter registration, conducts elections, prepares official ballots, and trains polling staff. The county is committed to providing clear and transparent voter services to Cumberland County residents.
