


Hotel Tax Monthly Reporting in Gov.OS

Login with your credentials.

You will arrive at the ‘Business Center’ when you log in... That page will look like this:

To file your monthly Hotel Tax Reports, go under the section ‘Open Tasks’. Here you will find links to submit your Hotel Tax Reports for the month/s due.

Once you click on the link to report, you are brought to the ‘Tax Exemption Declaration’ page...

If you are a hotel, select YES and attach your exemption report.

If you are an AirBNB, VRBO, Hopper, etc. select NO. – Exemptions do not apply to Booking Agent users.

If you are a hotel or collect rental earnings through a self-managed website with payments going directly to you, enter your gross receipt earnings in the yellow box on Line 1.

If you manage your rental bookings through a Booking Agent like AirBNB, VRBO, etc. Those agents collect and remit your hotel tax for you automatically through their website, enter all your gross receipt earnings in the yellow box in Line 7.

*NOTE: You will need to put a zero in Line 1 due to that field being required if entering Booking Agent gross receipts.

*Due to the Hotel Tax Ordinance 2023-2, it is required to submit a filing even if all funds are collected through a Booking Agent. Zero filings are required to be sent to the Treasurer's Office if no earnings are received for that month.

Hotel Tax Reports are required to be submitted to the Cumberland County Treasurer's Office monthly.*

Once everything has been entered in the appropriate lines, at the bottom of the reporting page, complete the required fields...

Click ‘COMPLETE TRANSACTION’ when finished

After you select ‘COMPLETE TRANSACTION’, you will be brought back to the ‘Business Center’, you can either leave the site, or file for another month if any reports are outstanding.

You will receive an E-Mail confirmation once your filing has been completed.

All hotel tax reports must be submitted to the Cumberland County Treasurer’s Office on or before the 20th of every month for the prior month that you are reporting.

Example: If you are to pay November 2025 hotel tax then the report is due on December 20th.
